All that lot of land on Greenville County, State of South Carolina, on the South side of Carolina Avenue, in the City of Greenville, being known and designated as lot No. 14 of Block J, Section 5, on plat of East Highlands Estates made by Dalton & Neves, Engineers, February 1941, recorded in the R.M.C. Office for Greenville County in Plat book K at Pages 78, 79 and 80 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Sou h side of Carolina Avenue, joint front corner of lots 14 and 15, of Block J, and running thence with the line of lot 15, S. 14-00 E. 126.3 feet to an iron pin; thence N. 87-14 E. 69.6 feet to an iron pin in the center of a 4-foot strip reserved for a ditch and public utilities; thence along the center of said strip, N. 19-46 W. 140 feet to an iron pin on the South side of Carolina Avenue; thence with the South side of Carolina Avenue along a curved line, S. 76-34 W. 54.1 feet to the beginning corner.

There is located partly on the east side of this lot and partly on the West side of lot 13 adjoining, a 4 foot strip shown on the recorded plat, over which an easement is reserved for the purpose of cutting and maintaining a drain ditch to drain the property shown on said plat and for the purpose of placing or authorizing the placing of any public utilities thereon with the right to enter and maintain the same, and for restrictions applicable to this property, see deed recorded in Book of Deeds 236 at Page 283.
