County. State of South Carolina, on Dukeland Drive between Christopher Street and Merriweather Street, in the Ethel Y. Perry Sub-Division in the Sans Pouci Section of Greenville County, about three miles north of the City of Greenville, said lot being known and designated as lot numbered fifty-one (51) on Plat of said property recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book "BB" at page 39, which Plat is hereby referred to and made a part hereof, and the said lot has the following lines, courses and distances:-

Beginning at an iron pin on the northern edge of a three (3) foot sidewalk running along Dukeland Drive, said pin being the joint front corner of lots farty (50) and fifty-one (51); thence along the northern edge of said sidewalk, 3. 54-18 W., fifty (50) feet, to an iron pin, joint front corner of lots fifty-one (51) and fifty-two (52); thence along the eastern line of lot fifty-two (52), N. 35-42 W., one hundred and twenty-six (126) feet, to an iron pin, rear corner of lots fifty-one (51) and fifty-two (52); thence F. 45-06 E., fifty and five tenths (50.5) feet, to an iron pin, rear corner of lots fifty (50) and fifty-one (51); thence along the western line of lot fifty (50), S. 35-42 T., one hundred and thirty-four (134) feet, to an iron pin the beginning corner.

This property is in a restricted district, and is sold subject to the following restrictions, which constitute a part of the consideration therefor, and shall be effective for a period of twenty-five (25) years from the date hereof:-

- (1) Said property shall be used for residential purposes only.
- (2) No residence shall be erected thereon at a cost of less than four thousand dollars (;4,000.00.).
- (3) No house shall be erected thereon nearer the northern edge of said sidewalk running along Dukeland Drive than twenty (20) feet.
