

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Faust Nicholson, John T. Douglas and T. Frank Huguenin, their heirs and assigns:

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, within the corporate Timits of the City of Greenville, and being known and designated as Lot No. 29 of a subdivision known as Essex Court, a plat of which is of record in the R.M.C. Office for Greenville County in Plat Book "W" at Page 31, and having the following metes and bounds, to-wit:

BEGINVING at a point on the East side of Essex Court at the joint front corner of Lots 28 and 29, said point being 555 feet North of the Northeastern intersection of Essex Court with County (Gilfillin) Road and running thence N. 86-15 E. 116.9 feet to a point at the joint rear corner of Lots 28 and 29; thence S. 5-52 E. 60.04 feet to a point at the joint rear corner of Lots 29 and 30; thence S. 86-15 W. 119.1 feet to a point on the East side of Essex Court at the joint front corner of Lots 29 and 30; thence with the East side of Essex Court, N. 3-45 W. 60 feet to the point of beginning.
