

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Robert L: Tomlin, Jr., his heirs and assigns, forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the Northerly side of Potomac Avenue, in the City of Greenville. South Carolina, being a part of Lot 198 and a part of Lot 199 of Pleasant Valley, as shown on a plat thereof recorded in the RMC Office for Greenville County, S. C. in Plat Book "P", page 114, and being more particularly shown as Lot No. 3 on the plat of the property of H. P. Asay, Jr. and T. G. Crymes, as recorded in said RMC Office in Plat Book "CC", page 107, and having according to said last mentioned plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northerly side of Potomac Avenue, at a point 874 feet West of the Northwesterly intersection of Potomac Avenue and Panama Avenue, said pin being the joint front corner of Lots Nos. 2 and 3, and running thence along the joint line of said Lots N 0-08 W 160 feet to an iron pin; thence S 89-52 W 72 feet to an iron pin, joint rear corner of Lots Nos. 3 and 4; thence along the joint line of said Lots S 0-08 E 160 feet to an iron pin on the Northerly side of Potomac Avenue; thence along the Northerly side of Potomac Avenue N 89-52 E 72 feet to the point of beginning.
