All that certain piece, parcel or lot of land, situate, lying and being in Butler Township, in the County of Greenville, State of South Carolina, being shown as Lot No. 96 on plat of College Heights made by Dalton & Neves, Engineers, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book P, at page 75, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Southeast corner of the intersection of Princeton Avenue with Columbia Circle and running thence along Princeton Avenue, N. 56-50 E. 158 feet to an iron pin at the corner of Lots Nos. 96 and 97 on Princeton Avenue; thence along the line of Lot 97, S. 34-44 E. 74.6 feet to iron pin; thence S. 25 E. 43.6 feet to an iron pin; thence along line of Lot No. 95, S. 71-32 W. 179 feet to an iron pin at the corner of Lots Nos. 95 and 96 on Columbia Circle; thence along Columbia Circle, N. 18-28 W. 75 feet to the beginning corner.
