BEGINNING at an I.P. which is the joint front corner between Lots 29 and 30 on the western edge of Chick Springs Road, and running thence the joint line between Lots 29 and 30, N. 75-20 W. across what was formerly a private drive to the center of the creek, a distance of approximately 1204; thence running the center of the creek as the line, approximately S. 46-18 W. to a point opposite the rear corner of Lots 27 and 28 as shown on said plat, a distance of approximately 170; thence S. 72-41 E. across said private drive and along the joint line between Lots 27 and 28 to their joint front corner on the western side of Chick Springs Road, a total distance of approximately 145' to their joint front corner; thence along the western edge of Chick Springs Road N. 35-25 E. across the front of Lots 28 and 29 to the joint front corner of Lots 29 and 30, a total distance of 170' to the beginning corner.
