NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, upon receipt of \$300.00

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Robert A. Henderson, all the right, title and interest of Alma L. Moore, the same being an undivided one-half interest in and to the following described real estate:

"All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Bates Township on the NW side, McElhanev Road, containing twenty-one (21) acres, more or less, and having the following metes and bounds, to-wit:

BEGINNING at a point in the center of McElhanev Road at the corner of the 90 acres tract heretofore conveyed by Fred R. Roach to the Brandon Corporation, and running thence along the center of said McElhanev Road, S. 67-05 W. 149 feet, more or less, to a bend in said road; thence still with the center of said road, S. 23 1/2 W. 394 feet, more or less, to a point in the center of said road at corner of property now or formerly belonging to Charlie Batson; thence along the line of the Batson property, N. 35 1/2 W. 2078.38 feet, more or less, to a stake at the corner of the 90 acre tract of the Brandon Corporation; thence along the line of the Brandon tract, N. 60-20 E. 489 feet to a corner of the Brandon tract; thence still with the line of the Brandon tract, S. 35-30 E. 1780 feet to the beginning corner in the center of the McElhanev Road; being the same conveyed to J.
