

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. E. Stafford, his heirs and assigns:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, lying and being situate on the Morthwesterly side of Knollwood Lane, within the limits of the City of Greenville, S. C., being a minor portion of the rear of Lots Mos. 164 and 165, according to plat of Cleveland Forest, prepared by Dalton & Neves, May, 1940, as revised through Cotober, 1950, as recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book M., at pages 56 and 57 and having, according to said plat, the following retes and bounds, to-wit:

BLGINNING at an iron pin on the Morthwesterly side of Knollwood Lane at common corner of Lots Nos. 165 and 166; thence on a straight line, N. 22-51 W. 89.1 feet to an iron pin; thence F. 69-07 W. 5.9 feet to an iron pin on the joint line of Lots Nos. 164 and 166; thence along the joint line of Lots Nos. 164 and 166, S. 25-25 E. 93.3 feet to an iron pin at common corner of Lots 103. 165 and 166 on the Northwesterly side of Knollwood Lane, the point of beginning.

The herein named grantee is to pay the 1953 taxes on the above describer property.

The above described property is subject to restrictions recorded in the R. H. C. Office for Greenville County, South Garolina, in Vol. K, pages 47 and 90. Said property is further restricted in that no residential building may be built thereon costing less than \$6,000.00, nor nearer than 50 feet to the street line. Any residential building built upon said lot shall face onto Knollwood Lane.
