

All that certain piece, parcel or lot of land in Grove Township, Green-ville County, State of South Carolina, in School district 85 on the North west side of Highway No. 29 and having according to a survey made by W.F.Adkins, Surveyor, Sept. 19th 1945, having the following metes and . bounds to wit ;-
