All that piece, parcel or lot of land, with the improvements thereon, situate, lying and being at the Northwestern corner of the intersection of Augusta Street and West Augusta Place in the City of Greenville, County of Greenville, State of South Carolina, and being all of Lots 1 and 2 and portions of Lots 34, 37 and 38 as shown on a plat entitled "Estate of D. W. Cochrane and Property of Minnie P. Cochrane" made by Dalton & Neves July, 1937, and recorded in the R. M. C. Office for Greenville County in Plat Book I, at pages 92 and 93, and having according to said plat and according to a plat entitled "Plat of Minnie P. Cochrane Property" made by Piedmont Engineering Service, August 1, 1947, and recorded in the R. M. C. Office for Greenville County in Plat Book R, at page 37, the following metes and bounds:

BEGINNING at an iron pin at the Northwestern corner of the intersection of Augusta Street and West Augusta Place, and running thence along the Southwestern side of Augusta Street N. 55-57 W. 340 feet to an iron pin at the Northeastern corner of Lot 1 (corner of property now or formerly of W. G. Gresham); thence along the line of property now or formerly of Gresham S. 35-07 W. 200 feet to an iron pin at the Northeastern corner of property of Westminster Presbyterian Church; thence along the line of property of Westminster Presbyterian Church S. 50-34 E. 230.1 feet to an iron pin; thence continuing along the line of property of Westminster Presbyterian Church S. 56-50 E. 100.3 feet to an iron pin on the Northwestern side of West Augusta Place; thence along the Northwestern side of West Augusta Place N. 37-56 E. 220 feet to an iron pin, the point of beginning.

The Grantor hereby expressly reserves unto herself a life estate in the within described premises for the term of her natural life
