All that lot of land with the buildings and improvements thereon, situate, on the Northeast side of Hampton Avenue Extension (also known as Cedar Lane Hoad) and formerly known as Finley Bridge Road, near the City of Greenville, Greenville County, S. C., and being shown as Lot "C" in a rearrangement of a tract of land composed of Lots 2, 3, and 4 of Marshal Addition as shown on plat made by J. N. Southern, Surveyor, December 9, 1897, which is recorded in the R. M. C. Office for Greenville County, S. C. in Deed Book "EEE", at Page 658 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeast side of Hampton Avenue Extension, said pin being 78 feet westward from the West side of Huff Street (formerly referred to as a new road connecting the Finley Bridge Road and the Buncombe Road) and running thence along the line of Lot D, N. 31 1/2 E. 120 feet to an iron pin on the Southwest edge of a 10 foot alley; thence along said alley N. 40 1/2 W. 50 feet to a stake; thence along the line of Lot B, S. 31 1/2 W. 120 feet to an iron pin on the Northeast side of Hampton Avenue Extension; thence along the Northeast side of Hampton Avenue Extension, S. 40 1/2 E. 50 feet to the beginning corner.

This lot is shown on the County Block Book on Sheet 149 in Block 9, as Lot 11. This is the same property that was conveyed to my husband, J. G. Scott by deed of R. M. Caine, dated November 24, 1942, recorded in the R.M.C. Office for Greenville County, S. C. in Deed Book 249, Page 196. Subsequently, J. G. Scott (John Gaston Scott) died testate May 17, 1946 and by his last will, which is on file in the Office of the Probate Court for Greenville County, S. C. in Apartment 513, File 20, he devised all of his property to the Grantor.
