KNOW ALL MEN BY THESE PRESENTS. That I, Fred M. Thompson ......

Beginning at a stake on Jamison Street, 300 feet east of the intersection of Valley and Jamison Streets and running thence along Jamison Street S. 53-40 E. 50 feet to iron pin, corner of lot 46; thence along line of lot 46 S. 42-43 W. 143.4 feet to iron pin, corner B. F. Martin property; thence along Martin property N. 46-32 W. 49.7 feet to iron pin, corner of lot 44; thence along line of lot 44 N. 42-43 E. 137.2 feet to the beginning corner on Jamison Street. Being the same lot conveyed to Edwin Bihari and Fred M. Thompson by deed of Joseph Alala dated March 31, 1950 recorded in deed volume 406 page 181.

Beginning at an iron pin on the southwest side of Jamison Street, corner of Lot No. 49; said pin being 434.9 feet west of Anderson Road, and running thence with line of said lot No. 49, South 42-43 West 161.9 feet to iron pin in line of property now or formerly of B. F. Martin; thence with said Martin's line North 46-32 West 49.7 feet to iron pin, corner of Lot No. 47; thence with line of said lot, North 42-43 East 155.7 feet to iron pin on Jamison Street; thence with Jamison Street South 53-40 East 50 feet to the point of beginning. This lot is shown on County Block Book at page 226, Block 7, lot 10, in School District 6 EW, and is the same conveyed to Edwin Bihari and Fred M. Thompson by Bennie H.
