to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said . Harold B. Kimbell, his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Westerly side of Sitka Lyenue, being known and designated as Lot Mo. 18 of Parkview, a plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book I, at page 49, and having, according to said plat, the following metes and bounds, to-wit:

BLGINNING at an iron pin on the Western side of Sitka Avenue, which iron pin is 210.5 feet South from the Southwestern intersection of Havil nd and Silke Austrics (this point if taken from projecting the lines of the two streets since the inter-(this point if taken from projecting the lines of the two streats since the intersection is a curve instead of a corner), joint corner of Lots Nov. 15 and 19, and numning thence along the joint line of said lots, 3. 63-15 W. 150 feet to an iron pin in the line of Nicholtown Roadformerly Meely Drive), (which point is 182 feet from the Southeastern intersection of Maviland Avenue and Micholtown Road (Cornerly Neely Drive); thence along the line of Nicholtown Road, 3. 26-15 E. 30 feet to an iron pin, rear joint corner of Lots Nos. 17 and 18; thence along the joint line of sid lots, N. 63-45 E. 150 feet to an iron pin in the line of Sitka Avenue; thence along the line of Sitka Avenue, N. 26-15 W., 50 feet to the point of beginning.
