

That I, John E. Upchurch, of the County of Greenville, in consideration of the sum of One Thousand and no/100-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Jessie Mae Upchurch, her heirs and assigns forever.

All that certain piece, parcel or lot of land on the South side of Sixth Street, in Section No. 4 of Judson Mills Village, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 68, as shown on a plat of Section No. 4 of Judson Mills Village, made by Dalton & Neves, Engineers, January 1941, which plat is recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book K, at pages 75 and 76, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Sixth Street, joint front corner of Lots 68 and 69, said pin also being 76 feet West from the Southwest corner of the intersection of Sixth Street and Hawkins Avenue, and running thence with the line of Lot 69 S. 1-00 E. 124.25 feet to an iron pin; thence with the rear line of Lot 56 S. 88-10 W. 81 feet to an iron pin; thence with the line of Lot 67 N.00-33 W. 124.5 feet to an iron pin on the South side of Sixth Street; thence with the South side of Sixth Street N. 88-22 E. 80 feet to the beginning corner.

This conveyance is made subject to the restrictions in deed from Judson Mills to John E. Upchurch dated March 1st, 1941, and recorded in R.M.C.Office for Greenville County, S.C. in Deed Book 232, page 3.
