All that piece, parcel or lot of land with the improvements thereon situate, lying and being in Monaghan Mills Village, Greenville County, South Carolina, and being more particularly described as Lot No.\_\_120\_, Section\_3\_\_\_\_, as shown on a plat entitled ZSubdivision for Victor-Monaghan Mills, Greenville, S. C.", made by Pickell & Pickell, Engineers, Greenville, S. C., TON LEVEL AND CONTROL OF SEASON O Smythe Street (XXXXX) and fronts thereon in described lot is also known as No. 1 \_\_\_\_100\_\_\_\_feet.

The grantor and its predecessors in title have granted unto Parker Water and Sewer Sub-District, Commissioners of Public Works of the City of Greenville, S.
