The said Nannie C. Moore who was one of the grantees in the deed from W. H. Bozeman, Jr. died intestate a number of years ago and by reason of her death the said Thomas R. Moore who was her husband acquired .a one-third (1/3) undivided interest of her one-half (1/2) interest in the said lands and her four children acquired a two-thirds (2/3) undivided interest in her share therein. Subsequently the four children of the said Nannie C. Moore have conveyed their separate interests in the parcel of land unto Rosa G. Moore, hence the said Rosa G. Moore prior to the execution of this instrument is the owner of a one-third (1/3) undivided interest in the said tract of land and the said Thomas R.
