Edwards, made by Dalton & Neves April 1948, and having according to said plat the following metes and bounds, to-wit: BEGINNING at an iron pin on the Southeast side of Super Highway No. 29, at the corner of property now owned by S. That no dwelling shall be erected upon said lots that shall cost less than \$10,000.00 (But this restriction shall not apply to servant's quarters, erected on the rear of said lot), nor less than 100 feet from the right-of-way of Highway No. 29. TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove Heirs and Assigns forever. named, and And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
