

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

.W. L. Ayers, his heirs and assigns, forever:

ALL that piece, parcel or lot of land being known and designated as Lot No. 61 of Wynette Estates, a subdivision of the M. W. Fore property, located approximately 2.4 miles South of Gantt Station in Greenville County, South Carolina, made by Pickell & Pickell, Engineers, dated May 26, 1953, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Wisconsin Avenue at the joint front corners of Lots No. 61 and 60 and running thence along the line of said Lot No. 60, N. 89-04 W. 180.24 feet to iron pin at back corner of Lot No. 46; thence along the rear line of said Lot No. 46, S. 5-46 W. 80 feet to iron pin at back corner of Lot No. 62; thence along the line of said Lot No. 62, S 89-04 E. 180.18 feet to iron pin on Wisconsin Avenue; thence with the said Wisconsin Avenue N. 5-48 E. 80 feet to iron pin at point of beginning.

THIS deed is made subject to easement for surface water drainage as is shown on said plat.

THAT the said lands shall not be sold, rented or otherwise disposed of to any Negro or person of African descent. No residence to cost less than Seven Thousand & Five Hundred (\$7500.00) Dollars, shall be erected on said lots; and no residence shall be erected on lots nearer the front line than building line as shown on plat; and no residence shall be built on any lot unless said lot has fifty (50) feet, or more, frontage; no outside toilets permitted and sewage to disposed of by approved septic tanks. The Grantor reserves to himself, his heirs and assigns, the right and easement in perpetuity to go upon the property herein granted for the right of installing, repairing, maintaining and locating electric power transmission lines.

TOCETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named,

Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named; and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomse
