All that piece, parcel or lot of land, situate, lying and being in Reidville Township, Spartanburg County, State of South Carolina and having the following metes and bounds, as found on plat of Greenville County Schools at Pelham, S. C. made. by Piedmont Engineering Service in April, 1953:

Beginning at an iron pin on the Pelham-Greer Highway, which pin is the joint corner of the present Pelham School property; thence S. 87-15 E. 79.2 feet to an old stone; thence N. 48-35 W. 259 feet to aniron pin; thence S. 79-21 E. 282.6 feet to an iron pin on the Pelham-Greer Highway; thence S. 7-32 E. 124.7 feet to the point of beginning, this being a portion of the property conveyed to me by E.
