Bruce and his heirs and assigns forever:

All of that parcel or tract of land in Oneal Township of Greenville County, South Carolina, lying on the South side of the Ansel School Road, about two miles North from the City of Greer, bounded on the North by said road and Loftis, on the East by lands of Rosa L. West, on the South by lands of W.D. West Estate, and on the West by lands of Austin Brown, containing Nine and 24/100 (9.24) acres, more or less, and having the following courses and distances:
