In addition to the foregoing, the grantor reserves to itself, its successors and assigns, all other water, sewer, electric light and electric power lines (other including all wires, poles, pipes, valves, fittings, hydrants, manholes and other apparatus and equipment used in connection with or forming a part of the successors and assigns, the right, privilege and easement at all times to go or to authorize and permit others to go upon said lot for the purpose of maingrantor further reserves to itself, its successors and assigns, the right successors and assigns, the right privilege and easement at all times to go or to authorize and permit others to go upon said lot for the purpose of maingrantor further reserves to itself, its successors and assigns, the right to construct or to authorize and permit others to construct, repair, and systems aforesaid. - (I) That no mercantile establishment, other than those already in existence, shall be erected, operated or maintained on the lot above described.
 - (2) That only one residence shall be erected or maintained on any one lot.

(3) That no livestock, except fowl, may be kept, stabled or penned thereon or brought to the premises.

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, and his (her or their) Heirs and Assigns forever.

And the said Woodside Mills, does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and his (her or their) heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
