Mundy in the State aforesaid, in consideration of the sum of - - - - - One and No/100 (\$1.00) - - - - - DOLLARS, and Love and Affection to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

RUTH M. CREECH, her heirs and assigns.

All that piece, parcel or lot of land, lying and being situate on the Southerly side of Lake Fairfield Drive, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot # 86, according to plat of Section 1 of Lake Forest, prepared by Piedmont Engineering Service, July, 1953, as recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "GG", page 17, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southerly side of Lake Fairfield Drive, a joint front corner of Lots # 86 and #87; thence along the joint line of those lots S. 27-30 E. 261.7 feet to a point where the joint line intersects the high water line of Lake Fairfield; thence along the high water line of the said lake, the traverse line of which is S. 44-37 W. 116.6 feet, to the point where the joint line of Lots # 85 and #86 intersect the high water line of the said lake; thence along the joint line of Lots # 85 and #86 N. 22-32 W. 221.6 feet to an iron pin at joint front corner of Lots # 85 and #86 on the Southerly side of Lake Fairfield Drive; thence along the said drive S. 65-53 W. 130 feet to an iron pin at joint front corner of Lots # 86 and #87 to point of beginning.

The herein named grantees are to pay the 1953 taxes on the above-described property.

The above-described property is subject to restrictions recorded in the R.M.C. Office for Greenville County, South Carolina, in Deeds Volume 485, at page 373. The said property is further subject to recorded easements and Rights of Way.
