

All that lot of land with the buildings and improvements thereon, situate on the northwest side of Rice Street (formerly known as Henrietta Avenue) in the City of Greenville, Greenville County, South Carolina, being shown as Lot No. 11 on plat of property of G. F. Cammer made by R. E. Dalton, Engineer, February 1923, revised December 1940, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "L", at Page 115, and having according to said the following metes and bounds, to wit:

BEGINNING at an iron pin on the northwest side of Rice Street at joint front corner of Lots 10 and 11 and running thence with the line of Lot 10, N. 36-24 W. 218.1 feet to an iron pin; thence S. 53-36 W. 75.8 feet to an iron pin; thence with the line of Lot 12, S. 36-24 E. 214.7 feet to an iron pin on the northwest side of Rice Street; thence along the northwest side of Rice Street, N. 56-12 E. 75.9 feet to the beginning corner.

This is the same property conveyed to the Grantor herein by deed of G. F. Cammer, dated September 2, 1946, recorded in the R. M. C. Office for Greenville County, S. C., in Deed Book 299, at Page 356.

The Grantee herein assumes and agrees to pay the balance of that mortgage given by Herman N.
