

All that piece, parcel or lot of land in the City of Greenville, State of South Carolina, known and designated as Lot No. Twenty-four (24) on plat of Carver Park Addition made by the Piedmont Engineering Service, February, 1953, and recorded in the R.M.C. Office for Greenville County in Plat Book DD, page 71, and having according to said plat the following courses and distances, to wit:

BEGINNING at an iron pin on Carter Street, joint front corner of Lots 24 and 25 and running thence along the line of Lot 25 S. 86-44 E. 118 feet to an iron pin corner of Lot 19; thence along the line of Lot 19 S. 7-51 W. 60.2 feet to an iron pin, corner of Lot 23: thence along the line of Lot 23 N. 87-12 W. 120 feet to an iron pin on Carter Street; thence along the line of Carter Street N. 9-10 E. 61.6 feet to the beginning corner.
