All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, about one mile east from Reir's School, lying on the south side of a new road, being bounded on the north by the said road and other lands of myself, on the east by lands of E. H. Green, on the south by lands of E. H. Green and myself and on the west by lands of Ben Siggleton, and being a part of the same land that was conveyed to me by deed from E. H. Green September 27th 1948, recorded in the R. M. C. office for Greenville County in Deed Book 360 at page 439, and having the following courses and distances, to wit:-

Beginning on a stake in the center of the said road at 33 feet from the joint corner of the Singleton lands and lands of mysel and runs thence with the Ben Siggleton line, S. 18-45 W. 391.2 feet to an iron pin on the said line (there is also an iron pin on the south bank of the said road at 40 feet); thence N. 48-31 E. 150.9 feet to a stake or iron pin, joint corner of the E. H. Green land and other lands of myself, then continueing with the same course 201.4 feet to an iron pin (making a total distance for this line 352.3 feet); thence with another of the E. H. Green lines, N. 8-34 W. 223 feet to a stake in the center of the said new road (iron pin back on lone at 28 feet); thence with the center of the said road, S. 50-51 W. 133.5 feet to the beginning corner, containing One and Eight One-hundredths (1.08) acres, more or less.
