I do hereby grant unto the said Georgia-Pacific Plywood Company all rights of ingress and egress together with all rights-of-way, privileges and easements on, over, upon and across said lands, which may be useful, convenient or necessary for cutting, removing and transporting of timber and trees on the lands hereinabove described or any other timber, trees or timber products whatsoever on the surrounding lands, together with the right to locate, construct and maintain over and across said lands such roads, tramways, skidders and equipment of every kind whatsoever, necessary or convenient for cutting and removing timber and timber products.

The grantee agrees not to cut any timber which immediately surrounds any of the houses located on the within described property.
