All that certain piece, parcel or lot of land situate on the north side of James Drive, near the City of Greenville, in the County of Greenville, State of South Carolina, shown as Lot No. 11 of Orderest Park, made by C. C. Jones, Engineer, July 1948, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "S", at Page 109, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of James Drive, joint front corner of Lots 11 and 12 and running thence with the line of Lot 12, N. 8-16 W. 160 feet to an iron pin; thence N. 81-44 E. 65 feet to an iron pin; thence with the line of Lot 10, S. 8-16 E. 160 feet to an iron pin on the north side of James Drive; thence along James Drive, S. 81-44 W. 65 feet to the beginning corner.

The above described property is the same conveyed to the grantor herein by deed of Eston L. Rodgers, dated September 18, 1953, recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 486, at Page 99.

The grantee assumes and agrees to pay the balance due on that mortgage given by Joe A. Austin to Fidelity Federal Savings and Loan Association, Greenville, S. C., in the original amount of \$5,000.00, dated February 28, 1952, recorded in the R.M.C. Office for Greenville County, S. C., in Mortgage Book 523, at Page 515.
