## PARCEL NO. 1

All that certain piece, parcel or tract of land situate, lying and being in Dunklin Township, Greenville County, South Carolina, containing  $61\frac{1}{2}$  acres, more or less, bounded by property now or formerly of R. B. Arnold, D. P. Ridgeway, James A. Scott; J. A. Traynham and W. M. Ridgeway, having the following metes and bounds, courses and distances, to-wit:

BEGINNING at a stone in a public road and running thence N. 67-30 E. 3.64 chains to a stone; thence S. 27-45 E. 8.10 chains to a stone; thence N. 46-45 E. 9.10 chains to a stone; thence S. 48-45 E. 22.15 chains to a stone; thence S. 52 W. 24.45 chains to a stone on the Western side of Little Horse Creek; thence N. 35 W. 3.46 chains to a corner in this creek; thence up the meanderings of Little Horse Creek to a corner of the creek at a bridge; thence up the public road to the beginning corner.
