KELLY SISK, Directors of said corporation, as its Statutory Liquidating Trustees, for and in consideration of the premises and in complete liquidation and retirement of all outstanding capital stock of PIEDMCNT REALTY CORPORATION, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto THE GREENVILLE NEWS-PIEDMONT COMPANY all the property, real and personal, choses in action, rights and franchises of every kind and description constituting the property and assets of the said PIEDMONT REALTY CORPORATION, including but not limited to all the following described tracts or parcels of real estate situate, lying and being in the County of Greenville, State of South Carolina, and being more particularly described as follows:

Tract, East side of North Main Street:
