


in the State aforesaid, in consideration of the sum of Three Hundred and No/100 - - - - - - (\$300.00) -- - DOLLARS, and the assumption of mortgage set out below to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee, E. W. Reeves, his heirs and assigns forever:

All that certain piece, parcel, or lot of land with the buildings and improvements the reon on the westerly side of McClain Avenue at the northwesterly corner of the intersection of McClain Avenue and Black Avenue, near the City of Greenville, S.C., being shown as Lot No. 8 on the plat of the property of Talmer Cordell as recorded in the R.M.C. office for Greenville County, S.C. in Plat Book Z, at page 113, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the northwesterly corner of the intersection of McClain Avenue and Black Avenue, and running thence with the northwesterly side of Black Avenue, S. 53-52 W. 83 feet to an iron pin; thence continuing along the northwesterly side of Black Avenue, S. 35-52 W. 103 feet to an iron pin; thence N. 14-0 W. 147.5 feet to an iron pin, joint rear corner of Lots Nos. 7 and 8; thence along the joint line of said lots, N. 76-0 E. 154.6 feet to an iron pin on the westerly side of McClain Avenue; thence along the westerly side of McClain Avenue, S. 14-58 E. 50 feet to the point of beginning; being the same conveyed to me by H. H. Grover by deed dated November 4, 1953 and recorded in the R.M.C. office for Greenville County in Vol. 491, at page 460.

The grantee herein expressly assumes and agrees to pay the balance due on a certain note and mortgage executed on July 10, 1951 in the sum of \$7.200.00 by Joseph L. Huff in favor of C. Douglas Wilson Company, recorded in the R.M.C. office for Greenville County in Mortgage Book 503, at page 453, said mortgage having been assigned to Federal National Mortgage Association, on which there is a balance due of \$6,406.18. The grantee also agrees to assume an F.H.A. Title 1 Home Improvement Loan executed by the grantor in the sum of \$1,000.00 in favor of First Federal Savings and Loan Association of Greenville.
