All that piece, parcel or lot of land just outside city limits of Greenville near White Horse Road on Easley Highway #29 in subdivision known as Rolando Hills, according to plat made July 1950 by Piedmont Engineering Company, recorded in RMC Office for Greenville County, in plat book "AA" at page 71, said lot being # 2, Block C, fronting on Larry Court, and being more particularly described as follows:

Detailed Description: Beginning at an iron pin on the North side of Larry Court, at the joint corners of Lots 1 and 2, thence along Larry Court N87-14W, 85 ft. to an iron pin thence N41E, 135.2 ft to an iron pin thence S70-54E, 144.8 ft to an iron pin, thence S10-40E, 120 ft to point beginning.

no residence shall be erected at a cost less than \$3000.00; nor nearer than 25' to the front line; nor shall any residence be erected on any lot unless said lot have 50' frontage or more.

no outside toilets are permitted and sewage must be disposed of by approved septic tank.

This deed is made subject to any rights of way which may have previously been given.
