

All those pieces, parcels or lots of land in Butler Township, Greenville County, State of South Carolina, on northwestern side of a New Road leading to a Highway and near its intersection with the Fish Hatchery Road, being shown and designated as Lots Numbers Two and Three (Nos. 2 and 3) on Plat No. 1 of the property of Baxter P. and Ellie Freeman, prepared by H.S.Brockman, April 30, 1952, and having the following metes and bounds, to-wit:

BEGINNING at a point, iron pin, on northwestern side of said New Road leading to Highway, at joint front corner of Lots Nos. 1 and 2, and running thence with said Road, N. 47-45 E. 200 feet to point, joint front corner with Lot No. 4 of said plat; thence N. 42-22 W. 272.5 feet along line of said Lot No. 4 to point, iron pin, joint rear corner with Lot No. 4; thence S. 14-45 W. 238 feet to point, iron pin, joint rear corner with Lot No. 1; thence S. 42-22 E. 142.2 feet along the line of said Lot No. 1, to the point of beginning.
