All that piece, parcel or tract of land with the buildings and improvements thereon, situate on the East side of U. S. Highway No. 25 leading from Greenville to Travelers Rest, S. C., and on both sides of the Paris Mountain Road, in Paris Mountain Township, Greenville County, South Carolina, containing approximately thirty-four acres, more or less, as shown on a plat of the property of Julia Barrow Robinson, made by W. J. Riddle, Surveyor, September 19, 1945, and recorded in Plat Book "B", Page 27, in the R. M. C. Office for Greenville County, South Carolina, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at a point in the center of U. 3. Highway No. 25 where the Paris Mountain Road leads off from said Highway and running thence along the center of said Highway No. 25, S. 13 E. 345 feet to a point in the center of said Highway; thence M. 75-15 L. 729.5 fact to a stake; thence S. 56-55 E. 844.2 feet to a stake; thence M. 45-30 E. 690.7 feet to an iron pin; thence M. 25-45 W. 1096 feet to a stake; thence crossing the Paris Mountain Road S. 55-30 W. -20.7 feet to a point in the center of the Paris Mountain Hoad; thence following the said Paris Mountain Road to the point of beginning M. 82 L. 1.4 feet to a point in the center of said Road; thence M. 72-15 W. 257.5 feet to a point in the center of said Road; thence S. 76-20 M. 100 feet to a point in the center of said Road; thence S. 36-2 M. 300 feet to a point in the center of said Road; thence S. 36-2 M. 300 feet to a point in the center of said Road; thence S. 36-2 M. 300 feet; thence S. 45 W. 52 feet to the point of beginning.
