

E. Dalton, Eingineer, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book F, pages 114 and 115, and having according to said plat and a recent survey thereof made by R. E. Dalton, October 8, 1938, the following metes and bounds,

BEGINNING at an iron pin on the South side of Byrd Boulevard, joint corner of Lots Nos. 159 and 160, said pin also being 404.7 feet in an Easterly direction from the Southeast corner of the intersection of Augusta Road and Byrd Boulevard, and running thence with the South side of Byrd Boulevard, S. 73-22 E., 75 feet to an iron pin, joint corner of Lots Nos. 158 and 159; thence with the line of Lot No. 158, S. 20-51 W., 234.6 feet to an iron pin; thence with the line of Lot No. 103, N. 54-08 W., 60 feet to an iron pin; thence with the line of Lot No. 160, N. 16-14 E., 213 feet to an iron pin on the South side of Byrd Boulevard, the beginning corner.
