




(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by thes

all that piece, parcel or lot of land in Chick Springs. Greenville Township,

County. State of South Carolina, on the south side of the Super Highway, about two miles West of the old city limits of Greer, near the present city limits of Greer, containing 10.2 acres, and being described by metes and bounds as follows:

BEGINNING on an iron pin on the south side of said Super Highway, corner of R. B. Taylor property, and running thence S. 67-27 W. 242.5 feet to a point or pin; thence N. 22-33 N. 25 feet to an iron pin on south side of said Super Highway; thence with the southern edge of said Super Highway S. 67-27 W. 690 feet to a point or pin in the center of the Old Buncombe road; thence with the center of the old Buncombe road S. 27-35 E. 512 feet to a point or pin in the center of the intersection of said old Buncombe road with the old Chick Springs road; thence with the center of the old Chick Springs road N. 58-10 E. 231 feet to a point in the bend of said road; thence continuing with the center of said road N. 64-10 E. 100 feet to a point in the bend of said road; thence continuing with the center of said road N. 67-55 E. 200 feet to a point in the center of said road; thence continuing with center of said road N. 71-05 E. 435.5 feet to an iron pin in center of said old Chick Springs road; thence N. 31-25 4. 169 feet to the beginning corner, and being the same as conveyed to me by deed of Margaret B. King, Sarah E. King, C. A. King, as Trustees, dated October 1, 1947, and recorded in Vol. 324, page 202.

Also, all that lot of land in Chick Springs Township, State and County eforesaid on the North side of the road leading from Greer to Locust Hill, otherwise known as the Sandy Flat Load, about 2 miles West from Greer and a short distance North from the intersection of said road with the super highway, same being in a triangular shape and having the following courses and distances, to wit: Beginning at a point or pin on the Northern edge of the said Sandy Flat Road on the line now or formerly of W. W.
