

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Olin S. Elliott, his heirs and assigns, forever:

All that lot of land with the buildings and improvements thereon, situate on the south side of East Tallulah Drive, in the City of Greenville, in Greenville County, S. C., being shown as the western one-half of Lot 15 on plat of property of D. T. Smith, made by C. M. Furman, Jr., Engineer, March 5, 1923, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book F, at Page 108, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of East Tallulah Drive, at joint front corner of Lots 13 and 15 and running thence with the line of Lot 13, S. 25-40 E. 200 feet to an iron pin; thence N. 64-20 E. 50 feet to an iron pin in the center of the rear line of Lot 15; thence through the center of Lot 15, N. 25-40 W. 200 feet to an iron pin on the south side of East Tallulah Drive in the center of the front line of Lot 15; thence with the south side of East Tallulah Drive, S. 64-20 W. 50 feet to the beginning corner.

This is the same property that was conveyed to Sam Karelitz and Anna Karelitz by deed dated June 19, 1947, recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 314, at Page 23. Subsequently, Anna (Ray) Karelitz died testate December 19, 1951 and by her last will which is on file in the Office of the Probate Court for Greenville County, S. C., in Apartment 607, File 60, she devised her interest in the above described property to the grantor, Sam Karelitz
