

ALL that lot of land with the buildings and improvements thereon, situate on the Southeast side of Crosby Circle, near the City of Greenville, in Greenville County, South Carolina, shown as Lot 129 on plat of Paramount Park, made by Piedmont Engineering Service, July, 1949, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "W", at page 57, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southeast side of Crosby Circle at joint front corner of Lots 128 and 129 and running thence with the line of Lot 128, S. 26-00 E., 150 feet to an iron pin; thence S. 64-00 W., 70 feet to an iron pin; thence with the line of Lot 130, N. 26-00 W., 150 feet to an iron pin on the Southeast side of Crosby Circle; thence along the Southeast side of Crosby Circle, N. 64-00 E., 70 feet to the beginning corner.
