



BEGINNING at an iron pin on South side of Goodrich Street, corner of Lot 75, which pin is 152.85 feet S. 64-49 E. from the intersection of Goodrich and Valley Streets, and running thence S. 36-15 W. 179.3 feet with the line of Lot #75 to an iron pin, corner of lot #53; thence with the line of said lot S. 59-23 E. 50.24 feet to iron pin, corner of Lot #77; thence with the line of said lot N. 36-15 E. 184.1 ft. to iron pin on Goodrich Street; thence with Goodrich Street N. 69-49 W. 50.95 feet to the beginning corner. (110-6-6) The above is the same conveyed to me by deed recorded in Deed Book 254, page 194. ALSO: All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the South side of Heatherly Drive, near the City of Greenville, being known and designated as Lot No. 23 on plat of property of Pride & Patton Land Company made by R. E. Dalton in June, 1920, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book E at Page 249, and described as follows: BEGINNING at a stake on the South side of Heatherly Drive, corner of Lot No. 24, and running thence with the line of said lot, S. 36-15 W. 210 feet to a stake, corner of Lot No. 22; thence with the line of said lot, N. 53-45 W. 61.7 feet to a stake in line of Heatherly property; thence with the line of said property, N. 38-00 E. 210.1 feet to a stake on Heatherly Drive; thence with the Southern side of Heatherly Drive, S. 53-45 E. 55.2 feet to the beginning corner. (226-1-7) The above is the same conveyed to me by deed recorded in Deed Book 238, page 343. ALSO:

All that piece of land in Greenville Township, Greenville County, State of South Carolina, on the Southern side of Hoyt Street, near the City of Greenville, being shown as Lot No. 4 on Plat of New Hope, made by P. S. Butler on October 16, 1904, recorded in Plat Book A at Page 307 and described as follows: BEGINNING at a stake on the Southern side of Hoyt Street, 165.5 feet West from Miller Street, at corner of Lot No. 3, and running thence with the line of said lot S. 13-45 W. 156 feet, more or less, to a stake, corner of Lot No. 17; thence with the line of said lot S. 81-20 W. 60 feet to a stake, corner of Lot No. 5; thence with the line of said lot N. 13-45 E. 156 feet, more or less, to Hoyt Street; thence with the Southern side of Hoyt Street, N. 81-20 E. 60 feet to the beginning corner. (135-2-7) The above is the same conveyed to me by deed recorded in Deed Book 443, page 51.
