- (6) The Lessor agrees that in the event the buildings on the said premises should be destroyed by fire or other casualty, the rent shall be abated until said buildings have been restored by the Lessor and if said buildings are not replaced within six (6) months after such destruction, the Lessee shall have the right to cancel this Lease.
- (7) This Lease shall not be assigned, or the leased premises sublet, without the written consent of the Lessor.
- (8) It is expressly agreed that if at any time during the period of this Lease, the Lessee shall be adjudged bankrupt or insolvent by any Federal or State Court of competent jurisdiction, the Lessor may, at his option, declare this Lease terminated and cancelled and take possession of said premises.
- (9) The Lessee covenants and agrees to indemnify and save the Lessor harmless from any and all claims, demands, suits, actions and judgments and recoveries for and on account of damages, injuries, (including death) to property or person of the Lessee, its agents, servants or other persons, caused by or due to the fault or negligence of the Lessee, its agents or servants, in the operation of said service station, and Lessee further agrees that no alcoholic beverages of any form whatsoever shall be handled otherwise on said premises.
