

All that lot of land with the buildings and improvements thereon, situate on the West side of Newman Street (formerly known as Austin Street), in the City of Greenville, in Greenville County, South Carolina, shown as a portion of Lots 50, 51 and 52 on plat of McDaniel Heights, made by Dalton & Neves, Engineers, April 1941, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "L", at page 47, (also being shown on plat of property of Louie Smith Gattis, Jr., recorded in said R. M. C. BEGINNING at an iron pin on the West side of Newman Street, said pin being 62.4 feet South from a bend in Newman Street, and running thence along the West side of Newman Street, S. 26-30 E. 62.5 feet to an iron pin; thence S. 86-11 W. 192.9 feet to an iron pin; thence N. 4-20 W. 55.7 feet to an iron pin; thence N. 85-30 E. 169.5 feet to an iron pin on the West side of Newman Street, the beginning corner.
