ALL THAT piece, parcel, or lot of land in Greenville County, State of South Carolina, being three lots numbered 1, 2, and 3 as shown on a plat of the same parcel by W. J. Riddle, Surveyor, dated September, 1954, and recorded in Plat Book CC at Page 56 office of the Register of Mesne Conveyances for Greenville County, and being more particularly described as follows:
