

All those pieces, parcels or lots of land situate, lying and being in the State of South Carolina, County of Greenville, bring known and designated as Lots Nos. 16 and 44 of a subdivision known as New Furman Heights, according to a plat thereof recorded in the R.M.C. Office for Greenville County in Plata Book EE, Page 75, and having, according to said plat, the following metes and bounds, to-wit:
LOT 16: BEGINNING at an iron pin on the southern side of Longforest Drive, joint front corner Lots 16 and 17 and running thence with the joint line of said lots, S. 25-00 W. 145.2 feet to an iron pin in the rear line of Lot No. 5; thence with the rear line of Lots Nos. 5 and 6, N. 74-02 W. 91.2 feet to an iron pin, joint rear corner Lots 15 and 16; thence with the joint line of said lots, N. 25-00 E. 159.1 feet to an iron pin on the southern side of Longforest Drive; thence with said dr. S. 65-00 E. 90 feet to the beginning corner.
LCT 44: BEGINNING at an iron pin on the eastern side of Courtland Drive, joint front corner of Lots 43 and 44 and running thence with the joint line of said lots, S. 84-30 E. 173.3 feet to an iron pin on the line of lot 45; thence along the line of that lot, S.5-30%, 87 feet to an iron pin,; thence N.84-30%. 173.3 feet to an iron pin on the eastern side of Courtland Drive; thence along the eastern side of Courtland Drive N. 5-30 E. 87 feet to beginning corner.
