STATE OF SOUTH CAMOULA 3: 03 PHILLSDING RESTRICTIONS AND PROTECTIVE COVENANTS APPLICABLE TO SECTION 3 OF .

A SUBDIVISION KNO... AS GREENFIELDS, FARNS NOCORDING TO A PLAT THEREOF, RECORDED R.M.C.IN THE R.M.C. OFFICE FOR GREENVILLE COUNTY IN PLAT BOOK GG, AT P.GE 93.

The following building restrictions and protective covenants are hereby imposed by the undersigned who is the owner of all lots in Section Three of a subdivision known as Greenfields, according to a plat thereof, recorded in the R. M. C. Office for Greenville County in Plat Book GG at page 93. These covenants are to run with the land and shall be binding on all persons claiming under them until December 1, 1979, at which time said covenants shall be automatically extended for successive periods of ten years unless by a majority of the then owners it is agreed to change said covenants in whole or in part.

If the undersigned, or her heirs or assigns, shall violate or attempt to violate any of the covenants herein contained, it shall be lawful for any other person or persons, owning any real property situate in said development or subdivision to prosecute any proceedings at law or in equity against the person or persons violating or attempting to violate any such covenant and either to prevent him or them from so doing or to recover damages or other dues for such violation. Invalidation of any one of the covenants by judgment or Court Order shall in no wise affect any of the other provisions, which shall remain in full force and effect.

- l. No lot shall be used except for residential purposes. No building shall be erected, altered, placed, or permitted to remain on any lot other than one detached single-family dwelling not to exceed two and one-half stories in height and a private garage for not more than two cars.
- 2. No building shall be erected, placed, or altered on any building plot in this subdivision until the building plans (ircluding front, side and rear elevations), specifications (ircluding construction materials) and plot plan showing the location of such building has been approved in writing as to conformity and harmony of external design with existing structures in the subcivision, and as to location of the building with respect to topography and finished grade elevation by a committee composed of G. F. Thompson, Haskell Hartin, or by a representative resignated by a L. M. Mahon majority of the members of said committee. The undersigned property owner reserves the right to change or increase the membershir of said committee at any time. In the event of death or resignation of any member of said committee, the remaining member or members sna 1 lave full authority to approve or disapprove such design and location, or to designate a representative with such authority. In the event said committee, or its designated representative, fails to approve or disapprove such design and location within thirty ( ) days a ter sold plans and specifications have been submitted to it, or in any event, if no suit to enjoin the erection of such building or the making of such alterations has been commenced prior to the completion thereof, such approval willnot be required and this covenant will be dermed to have been fully complied with. Neither the memoers of such committee, nor its designated representative, shall be entitled to any convensation for service performed pursuant to this covenut. The powers and duties of such committee, or its designated representative, such cease on and after December 1, 1979. Thereafter the approval december in this covenant shall not be required unless, prior to said date, and effective thereon a written instrument shall be executed by the tear record owners of a majority of the lots in this subdivision and dury recorded, appointing a representative, or representative, who scall theres ter exercise the same powers previously exercised by said cormittee.
