KNOW ALL MEN BY THESE PRESENTS. That I, John Haring

in the State aforesaid, in consideration of the sum of One and No/100ths (\$1.00) Dollars  
and love and affection  
to me in hand paid at and before the sealing of these presents  
by Monica H. Haring

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these  
presents do grant, bargain, sell and release unto the said Monica H. Haring, her heirs  
and assigns, forever, an undivided one-half interest in and to the  
following pieces or parcels of land:

all that piece, parcel or lot of land in Paris Mountain Township, Greenville

County, State of South Carolina, on the Northwest side of Crestline Road, near  
the City of Greenville, being Lot No. 11 and a portion of Lot No. 9,  
Block A, of Hillandale Estates, a plat of which is recorded in the  
R. M. C. Office for the County and State aforesaid in Plat Book Y  
at page 113, and having, according to a plat prepared by Piedmont  
Engineering Service on October 9, 1953, recorded in the R. M. C.  
Office for the County and State aforesaid in Plat Book DD at page  
20, the following metes and bounds, to-wit:

BEGINNING at a point on the Northwest side of Crestline  
Road, which point is approximately 960.4 feet from the intersection  
of said Road and Davidson Road, and running thence N. 62-10 W. 185.5  
feet, along a wall, to a point; thence N. 27-52 E. 33.9 feet to a  
point; thence S. 53-46 E. 192.4 feet to a point on the Northwest  
side of Crestline Road; thence S. 27-17 W. 1.1 feet to the beginning  
corner, this being a portion of Lot No. 9.

ALSO: BEGINNING at a point on the Northwest side of Crestline  
Road, the joint front corner of Lots No's 10 and 11, and running  
thence N. 55-47 W. 252.4 feet to a point; thence N. 34-26 E. 20  
feet to a point; thence N. 13-15 E. 46 feet to a point on an alley;  
thence along said alley N. 42-30 E. 17.3 feet to a point; thence  
S. 57-54 E. 259.5 feet to a point on the Northwest side of Crestline  
road; thence S. 28-33 W. 89 feet to the point of beginning, this being  
Lot No. 11.

ALSO: All those portions of lots situate on the Northwest side of  
Crestline Road, near the City of Greenville, in Paris Mountain Town-  
ship, County and State aforesaid, shown as portions of Lots No's 9  
and 10, Block A, of Hillandale Estates, a plat of which is recorded  
in the R. M. C. Office for the County and State aforesaid in Plat  
Book Y at page 113, and having according to a plat prepared by Pied-  
mont Engineering Service on October 9, 1953, recorded in the R. M. C.  
Office for Greenville County in Plat Book DD at page 20, the following  
metes and bounds, to-wit:
