
## STATE OF SOUTH CAROLINA

ALL that piece, parcel or tract of land lying and being situate in Gantt Township, Greenville County, State of South Carolina, and being known and designated as Lot No. 81 on plat of property of Chestnut Hills, dated March, 1954, recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book GG at Page 35, and being more particularly shown on plat of property of William T. BEGINNING At an iron pin on the East side of Chipley Lane at the joint front corner of Lots 80 and 81 and running thence along the joint line of said lots S. 89-19 E. 155.8 feet to an iron pin at the joint rear corner of Lots 80 and 81; thence turning and running N. 5-25 E. 65 feet to an iron pin at the joint rear corner of Lots 81 and 82; thence turning and running along the joint line of Lots 81 and 82, N. 83-58 W. 163.5 feet to an iron pin, joint front corner of Lots 81 and 82; thence turning and running along the East side of Chipley Lane, S. 0-33 E. 80 feet to the point of beginning.

This property is subject to restrictions and existing easements.

As part of the consideration for this deed, grantee assumes and agrees to pay that certain mortgage from the grantor to First Federal Savings & Loan Association of Greenville, S.
