

All that certain piece, parcel or lot of land, situate, lying and being on the easterly side of Davis Drive, Welcome School District, near the City of Greenville, S. C., containing 2.2 acres, more or less, being shown on plat made by J. Mac Richardson recorded in the RMC Office for Greenville County, S. C. in Plat Book "HH", page 81, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Davis Drive, joint front corner of lot previously conveyed by the grantor to the grantees herein (see Deed Book 500, page 396), and running thence along the easterly side of Davis Drive N 11 E 14 feet, more or less, to corner of Southerland Tract (for deed into Southerland see Deed Book 470, page 339); thence along the Southerland line S 80 E 606.5 feet (this call on the Richardson plat above referred to being S 80-51 E 596.4 feet) to branch; thence along said branch in a southerly direction 292 feet, more or less, to an iron pin, joint rear corner of property belonging to the estate of R. J. Rowley, deceased; thence along the Rowley line N 76-30 W 329.1 feet (this call on the Richardson plat being N 75-46 W 319 feet) to an iron pin, joint corner of the lot previously conveyed by the grantor to the grantees in Deed Book 500, page 396; thence along the property of grantees herein N 11 E 150 feet (this call on the Richardson plat being N 13-18 E 150 feet) to an iron pin; thence continuing along lot of grantees N 62 W 200 feet (this call on Richardson plat being N 63-58 W 200 feet) to an iron pin, the point of beginning.

The property herein conveyed is bounded by a branch and property of William B. Rogers, et al. on the east; property of Southerland on the north; property of the Estate of R. J.
