to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

grantee, Hattie Hammond, her Heirs and Assigns forever, ALL of our right, title and interest in and to all that certain piece parcel or tract of land situate, lying and being in the State and County aforesaid, Oneal Township, about one mile north from Oneal, lying west from the Gap Creek Road, being bounded on the familiaer of the former J. O. Hammond land (of which the tract described herein is a part), on the east by a county road and lands now or formerly of Poole, on the south and west by lands of Malcolm Mason, and being a part of the same tract that was conveyed to the grantors herein and to the grantee herein by deed from J.
