

All that piece, parcel or lot of land situate, lying and being on the North-eastern side of Old Stage Road near Simpsonville, in the County of Greenville State of South Carolina, and known and designated as Lots 83 and 84 as shown on a plat entitled "Map of Roland Heights" made by W. J. Riddle, Surveyor, July, 1950, and recorded in the R. M. C. Office for Greenville County in Plat Book S at page 34 and having according to said plat the following metes and

BEGINNING at an iron pin on the Northeastern side of the Old Stage Road at the joint front corner of Lots 82 and 83 and running thence with the common line of said two lots N. 52-16 E. 400.3 feet to a point in the center line of the C.&W.C. Railroad; thence with the center line of said railroad N. 43-14 W. 129.4ft. to the joint rear corner of Lots 84 and 85; thence with the common line of said two lots S. 52-16 W. 359.4 feet to an iron pin on the Northeastern side of Old Stage Road; thence with the Northeastern side of Old Stage Road; thence with the Northeastern side of Old Stage Road; thence with the Point of beginning.

All that piece, parcel or lot of land situate, lying and being on the North-eastern side of Old Stage Road near Simpsonville, in the County of Greenville, State of South Carolina, and known and designated as Lot 89 as shown on a plat entitled "Map of Roland Heights" made by N. J. Riddle, Surveyor, July, 1950, and recorded in the R. M. C. Office for Greenville County in Plat Book S at page 34 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northeastern side of the Cld Stage Road at the joint front corner of Lots 88 and 89 and running thence with the common line of said two lots N. 52-16 E. 292.4 feet to a point in the center line of the C.&W.C. Railroad; thence with the center line of said railroad N. 43-14 W. 57.6 feet; thence S. 54-00 W. 286.5 feet to an iron pin on the Northeastern side of Old Stage Road; thence with the Northeastern side of Cld Stage Road S. 37-24 E. 66 feet to an iron pin, the point of beginning.

The above described lots constitute a portion of the property conveyed to the grantor herein by Jeff R. Richardson, Trustee, by his deed dated September 22, 1950, and recorded in the R. M. C. Office for Greenville County in Deed Book 419 at page 426.
