All that certain piece, parcel or lot land in the State of South Carolina, County of Greenville, Greenville Township, in the City of Greenville, being known and designated as Lot No. 77 as shown on a plat of Dixie Heights recorded in Plat Book H at Page 46, and being more particularly described according to said plat as follows:
