

ALL That certain piece, parcel or tract of land lying and being situat in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 125, Section C, according to plat of property of Woodfields, Inc., prepared by C. C. Jones, and being more particularly shown on plat of property of Joseph Ralph Warren, dated January 11, 1955, prepared by C. C. Jones, Engineer, and having according to said plat the following metes and bounds, to-wit:

BEGINNING At an iron pin on the northwest side of Ridgeway Drive at the joint front corner of Lots 124 and 125, and running thence along Ridgeway Drive N. 81-11 E. 100.0 feet to an iron pin; thence running along the curve at the intersection of Pine Creek Drive and Ridgeway Drive, the chord of which is N. 36-50 E. 35.2 feet, to an iron pin on Pine Creek Drive; thence along Pine Creek Drive N. 7-44 W. 110.2 feet to an iron pin at joint rear corner of Lots 125 and 126; thence turning and running along the joint line of Lots 125 and 126 S. 82-14 W. 125.0 feet to an iron pin at joint rear corner of Lots 124, 125 and 126; thence turning and running along the joint line of Lots 124 and 125, S. 7-36 E. 135.6 feet to an iron pin on Ridgeway Drive, the point of beginning.
